To whom it may concern,

I, Justo Tapia, father of Denis Tapia, identity number 406-280846-0001A. I hereby declare the following:

My son, Denis Tapia, was forced to leave Nicaragua due to the political persecution he has faced since 2018. From that moment on, groups identified as Sandinistas began to harass, intimidate, and threaten him constantly because he didn't agree with the government.

The situation was so serious that they intended to strip him of his home. As a protective measure against this risk, he made the decision to transfer the property to my name so that it wouldn't be taken by these people.

Additionally, my son has lived through high-risk situations in his work environment, when had to stay locked inside out of fear of being assaulted. In the streets, Sandinista groups attacked those who didn't share their ideology, robbing, beating, and causing them harm.

Due to constant threats and danger he faced, my son made the decision to leave the country to protect his life and integrity, looking for a place where he could live in peace and safety.

I declare that the information above is true and correct to the best of my knowledge and personal experience.

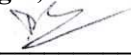

La situación llegó a ser tan grave que incluso existía la intención de despojarlo de su vivienda. Como medida de protección ante este riesgo, se tomó la decisión de poner la propiedad a mi nombre, con el fin de evitar que fuera tomada por estas personas.

Asimismo, mi hijo vivió situaciones de alto riesgo en su lugar de trabajo, donde tuvo que permanecer encerrado por temor a ser agredido. En las calles, los grupos sandinistas atacaban a quienes no compartían su ideología, robándoles, golpeándolos y causándoles daño.

Debido a las constantes amenazas y al peligro que enfrentaba, mi hijo tomó la decisión de salir del país para proteger su vida y su integridad, buscando un lugar donde pudiera vivir en paz y seguridad.

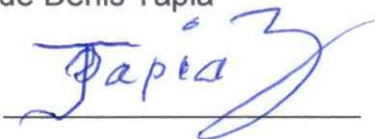

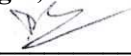

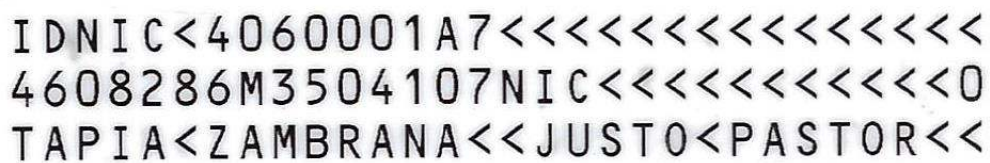

To whom it may concern,

I, Gabriel Tapia, son of Denis Tapia, identity number 001-010607-1014X. I hereby declare the following:

My father, Denis Tapia, was born in Nicaragua and was forced to leave his country due to the political persecution he has faced since 2018. After this year, pro-government groups, known as Sandinistas, began to harass, intimidate, and threaten him constantly because he shared neither the ideas nor the conduct of the current government.

These actions were not limited to verbal threats, but also included more serious intimidation attempts, like stripping him of his home. As a result of this risky situation, he made decision to transfer his home to his father's name, Justo Tapia, as a protective measure against any possible removals.

The harassment was such that, on one occasion, on his way back home from work, my father was a victim of robbery and ended up wounded by a group of Sandinista supporters. Using a bladed weapon, they wounded and beat him in order to rob him of his belongings, seriously endangering his physical integrity.

Additionally, my father lived through times of much fear in his work environment. On some occasions he had to remain locked inside his workplace because groups of Sandinistas in the streets attacked people who disagreed with the government. These people were victim of robbery, assault, and other harm.

Due to constant threats and fear for his safety and physical integrity, my father made a hard decision, leaving Nicaragua in order to protect his life and live in a safe environment where he could feel at peace.

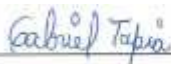

Mi padre, Denis Tapia, es originario de Nicaragua y se vio obligado a abandonar el país debido a la situación de persecución política que enfrentó a partir del año 2018. Después de ese año, grupos afines al gobierno, conocidos como sandinistas, comenzaron a acosarlo, hostigarlo y amenazarlo constantemente debido a que él no compartía las ideas ni el actuar del gobierno actual.

Estas acciones no solo se limitaron a amenazas verbales, sino que también incluyeron intentos de intimidación más graves, como el querer apropiarse de su vivienda. Debido a esta situación de riesgo, se tomó la decisión de poner la casa a nombre de su padre, Justo Tapia, como medida de protección ante posibles despojos.

Fue tanto el nivel de acoso que, en una ocasión, regresando a su casa desde su lugar de trabajo, mi padre fue víctima de un robo y resultó lesionado por un grupo de simpatizantes sandinistas. Estas personas, utilizando un arma blanca, lo hirieron y golpearon con el fin de despojarlo de sus pertenencias, poniendo en grave riesgo su integridad física.

Además, mi padre vivió momentos de mucho temor en su entorno laboral. Hubo ocasiones en las que tuvo que permanecer encerrado en su lugar de trabajo, ya que en las calles se encontraban grupos sandinistas que agredían a las personas que no estaban de acuerdo con el gobierno. Estas personas eran víctimas de robos, agresiones físicas y otros daños.

Debido a las constantes amenazas y al miedo por su seguridad e integridad física, mi padre tomó la difícil decisión de salir de Nicaragua, con el objetivo de resguardar su vida y poder vivir en un ambiente seguro, donde pudiera sentirse tranquilo.

Declaro que la información anteriormente expuesta es verdadera según mi conocimiento y experiencia personal.

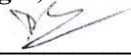

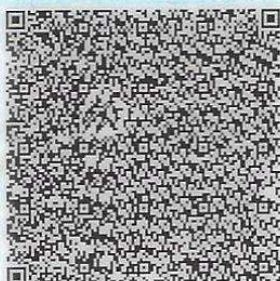

I know that during his last years in Nicaragua he lived through some difficult situations due to his political opinions and involvement in civic and social activities.

I know that he was involved in or expressed opinions relating to the country's political situation, especially after the events that have taken place since 2018. As a result, he began to experience apprehension and concerns relating to comments, surveillance, and being targeted by pro-government people or local authorities.

Due to these circumstances, I noticed that **Denis** was feeling concerned about his safety and possible consequences he might face in Nicaragua. Over the time, he decided to leave the country in search of peace and stability.

I believe his decision to request asylum in the United States was made out of fear of facing further problems related to his political opinions or political background.

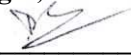
