I have known José Naen Romero Ponce personally all my life; we have lived together since childhood, and I can confirm that he is a person of good character, hardworking, with no criminal record or history of criminal behavior. José Naen Romero Ponce faced great difficulties in Honduras during the time I have known him. I witnessed the violence and insecurity that José Naen experienced in this country, where he lost his father due to the violence that was sweeping the country. On October 22, 1998, his father was killed by members of criminal groups residing in the area. José Naen also told me that he received threats from members of the same criminal groups. I am convinced that José Naen is afraid to return to Honduras because of the insecurity he faces in the country. Therefore, I respectfully request that the competent authorities consider this testimony in support of José Naen's asylum application, recognizing the validity of his allegations and the importance of offering humanitarian protection in the United States. 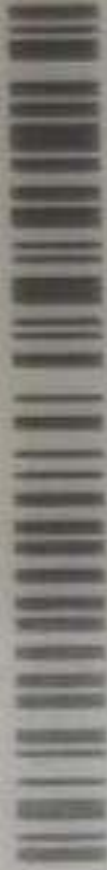

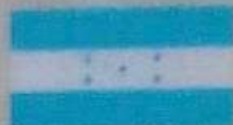
