Undersigned counsel continues to review the record, consult with Respondent, and evaluate the appropriate procedural measures and forms of relief available. Respondent expressly reserves the right to seek withdrawal, amendment, or other appropriate disposition of the previously filed Form I-589, as well as to pursue any other relief for which she may be eligible.

Good cause exists for acceptance of this untimely filing. Respondent acted diligently in curing the outstanding issue promptly once she became aware of the payment obligation through undersigned counsel. Moreover, acceptance of the proof of payment will allow the case to proceed in compliance with this Court's prior order without causing any prejudice to the Department of Homeland Security. Accordingly, acceptance of this filing serves the interests of justice and procedural efficiency.

Accordingly, Respondent respectfully requests that this Honorable Court accept the attached payment receipt, deem satisfied the requirement to pay the initial filing fee associated with Form I-589, and grant Respondent a reasonable opportunity to clarify her applications for relief following completion of counsel's review of the record.
