To Contra Costa County District Attorney,

Our office represents Ms. Eduarda de Alencar Gonçalves in connection with her U nonimmigrant status petition. We respectfully submit this request for certification of Form I-918, Supplement B, regarding a qualifying criminal activity investigated by your office on February 15, 2025, involving suspect Martin Portillo-Rodriguez.

Although Ms. Gonçalves is not listed as the primary victim in the police report, she was directly targeted and profoundly affected by the suspect's aggression on the date of the incident. According to the report, the suspect assaulted her mother and subsequently approached Ms. Gonçalves in an aggressive and threatening manner.

We wish to emphasize specifically that **Ms. Gonçalves had been a victim of a continuous and ongoing pattern of domestic violence perpetrated by the suspect, who was her stepfather at the time, on numerous occasions prior to the date of this report.** The incident on February 15, 2025, was one of many instances in a long history of abuse she suffered at his hands. This prior history of violence is what fueled her intense fear during the confrontation and led to the issuance of an emergency protective order and a subsequent restraining order for her protection.

As a result of this prolonged and repeated domestic violence, Ms. Gonçalves has suffered severe and lasting psychological, emotional, and physical harm. She continues to experience trauma-related symptoms, including intense fear and anxiety. Recently, Ms. Gonçalves suffered a severe episode of emotional distress triggered by a situation that reminded her of the abuse endured from her former stepfather. This crisis was so acute that it manifested in significant neurological symptoms, leading her to seek urgent medical attention. Following specialized neurological evaluations and testing, **she is currently in the process of being diagnosed with Multiple Sclerosis.** The timing and severity of these symptoms highlight the profound physiological toll that the sustained trauma and fear have taken on her health. The cumulative effects of this abuse continue to pose significant and debilitating challenges to her daily life and overall well-being.

In light of these facts, we respectfully request the certification of the enclosed Form I-918 Supplement B, explicitly recognizing Ms. Gonçalves as a victim of ongoing domestic violence who has been helpful to law enforcement.

The criminal activity involves domestic violence on Feb 15, 2025, involving Martin Portillo-Rodriguez. According to the police report, the primary victim, Roberta de Alencar, was assaulted when the suspect, her husband at the time, grabbed her by the neck. The petitioner, Eduarda de Alencar, her daughter, became involved when he aggressively approached her. Fearing for her safety and due to prior domestic violence she suffered from her stepfather, she used pepper spray in self-defense. Eduarda suffered a pattern of domestic violence by her stepfather at the time of the facts, which fueled her fear and involvement during the incident. Petitioner holds restraining order.

As a result of the incident and ongoing history of domestic violence, the petitioner has suffered significant psychological and emotional harm. She experienced intense fear for her safety. Since the incident, she continues to experience symptoms consistent with trauma. The petitioner has experienced ongoing stress and psychological harm due to the pattern of abuse, which has contributed to serious health issues affecting her daily life.

The caller, later identified as Eduarda De Alencar Goncalves (hereafter referred to as Goncalves), advised that her stepfather, later identified as Martin Jesus A Portillo-Rodriguez (hereafter referred to as Portillo-Rodriguez), was drunk and hitting the victim.

RELATIONSHIP:

Portillo-Rodriguez is the husband of the victim. They have been married since 12/30/2023 and live together with the victim's daughter on 1841 Laguna St, Apt 223, Concord, CA 94520. The victim's daughter, Goncalves is the stepdaughter of Portillo-Rodriguez. Portillo-Rodriguez and the victim do not have biological children.

PREVIOUS DOMESTIC VIOLENCE:

No priors according to victim, suspect, and witness.

INJURIES:

Victim complained of pain on top of her right hand, and around her left elbow. Bruising was visible on both areas. She was later transported to John Muir Concord by AMR and signed a CPD Medical Records Release form.

NARRATIVE:

On 02/15/2025 at approximately 2323 hours, I was dispatched to 1841 Laguna St. for a report of a domestic disturbance. Prior to my arrival, there were CPD Officers on scene who found Portillo-Rodriguez and the victim arguing. Portillo-Rodriguez was then detained by Officer N. Oliva in handcuffs and transported to John Muir Hospital in Concord due to being pepper sprayed in the eyes (refer to Officer N. Oliva's supplemental report). Upon my arrival, I came in contact with the victim, who gave me a summary statement that the following had occurred:

Victim Statement:

On 2/15/2025 at approximately 1600 hours, the victim advised that she was at the Todos Santos Plaza with Portillo-Rodriguez. The victim advised that she wanted to go to Sacramento on a date with Portillo-Rodriguez. Portillo-Rodriguez got upset because it was too late, and an argument had begun. The victim stated that she then left Portillo-Rodriguez at the Todos Santos Plaza and drove back to her residence on 1841 Laguna St. The victim advised that Portillo-Rodriguez began to drink at various bars around Todos Santos and eventually walked back to their residence at approximately 2200 hours. The victim advised that Portillo-Rodriguez called her and requested that she let him go inside her vehicle in order to listen to music. Out of fear of Portillo-Rodriguez attempting to drive after becoming intoxicated, she refused to let him inside of her car and he became angrier. The victim advised that she convinced Portillo-Rodriguez to go inside of the residence where they continued to argue. The victim stated that while they were arguing, she turned her back to Portillo-Rodriguez in which he suddenly wrapped his arm around her neck, pulled her back, and held her in a hold. The victim advised that Portillo-Rodriguez had a firm hold on her, but not enough to restrict her breathing or cause her to lose consciousness. The victim advised that she was able to get herself out of the hold but injured herself in the process. The victim stated that Portillo-Rodriguez then aggressively walked towards her daughter Goncalves, and Goncalves then pepper sprayed Portillo-Rodriguez out of fear.

The victim advised that she then began to try and help Portillo-Gonzalez wash his eyes, but he kept screaming and shouting at her and her daughter. The victim advised that Portillo-Rodriguez threw punches towards her direction and no contact was made. Shortly after, CPD officers had arrived.

Witness Statement:

After getting a statement from the victim, I came in contact with Goncalves, and she gave me a summary statement that the following had occurred:

On 2/15/2025 at approximately 1600 hours, Goncalves advised that the victim and her stepfather Portillo-Rodriguez had gone on a date to the Todos Santos Plaza. Goncalves stated that Portillo-Rodriguez stayed at Todos Santos and began drinking while the victim drove back to their residence. Portillo-Rodriguez returned to the apartment complex and asked the victim to let him get inside of her vehicle to listen to music. After back-and-forth arguments, Goncalves advised that they convinced him to go upstairs and go inside their residence. Goncalves advised that Portillo-Rodriguez continued to argue with the victim and suddenly grabbed the victim by the neck while she had her back turned on him. Goncalves advised that the victim was able to free herself from the hold and then Portillo-Rodriguez aggressively approached Goncalves. Due to what had just happened, Goncalves stated that she was in fear of what Portillo-Rodriguez might do to her. Goncalves advised that she then pepper sprayed him and called 911 while the victim was attempting to help Portillo-Rodriguez flush his eyes out. Goncalves advised that there is a surveillance camera in the living room pointing towards the hallway that captured the argument.

Suspect Statement

* It should be noted that while I contacted Portillo-Rodriguez, I observed red watery eyes, slurred speech, and a strong alcohol-like odor emitting from his breath and person. Based on my training and experience, I know these are objective symptoms of intoxication *

On 2/16/2025 at approximately 0206 hours, I placed Portillo-Rodriguez under arrest for 273.5 PC. I advised Portillo-Rodriguez of his Miranda Rights, reading them directly from my Concord Police Department issued Miranda Rights Advisement Card. Portillo-Rodriguez implied that he understood his rights and agreed to give a statement.

Portillo-Rodriguez stated in summary that following had occurred:

Portillo-Rodriguez stated that he was in downtown Concord with the victim. He advised that they got in an argument because the victim wanted to go out of town, but he thought it was too late. He then stayed in downtown and began going to bars while the victim left home to their residence. Portillo-Rodriguez advised that at approximately 2200 hours, he walked back to the apartment complex and wanted to listen to music in the victim's vehicle. Portillo-Rodriguez advised she did not allow him to, so he went inside of the residence. He then advised that they continued to argue but quoted "I never put my hands on anybody". Portillo-Rodriguez stated that as he was arguing with the victim, Goncalves pepper sprayed him for not reason. He then advised that the victim began helping him wash his eyes.

EPO:

Per the request of the victim, and Emergency Protective Order was issued by the honorable Judge Burch on 2/15/2024 at approximately 0144 hours.

I served the EPO to Portillo-Rodriguez, gave a copy of the EPO to the victim, and had dispatch enter the EPO into their system.

Both the victim and Portillo-Rodriguez were transported by AMR to John Muir Hospital in Concord.

I took pictures of the victim's injuries and uploaded them to Evidence.com.

I provided Goncalves with an axon link to upload surveillance of the incident. Goncalves sent four videos that showed the following:

Video 1: Shows Goncalves calling 911 and standing near the entrance door. Coughing and arguing is heard in the background.

Video 2: CPD officers enter the residence and detain Portillo-Rodriguez

Video 3: Victim and Goncalves begin to tell the CPD officers what is going on.

Video 4: CPD officers begin getting the Victim and Goncalves' information.

The surveillance videos do not capture the alleged physical altercation between victim and Portillo-Rodriguez.

I asked the victim if Portillo-Rodriguez owned or had any firearms in the residence and she said no. Dispatch conducted an automated firearms system check on Portillo-Rodriguez with negative results.

The victim was provided with a case number, a Marsy's Pamphlet, a copy of the emergency protective order and my contact information.

It should be noted that on 2/16/25 at approximately 2007 hours, I came in contact with the victim via telephone call for some follow-up questions. The victim advised that right before the domestic violence incident occurred, Portillo-Rodriguez grabbed a piece of broken and threatened to cut his wrist.

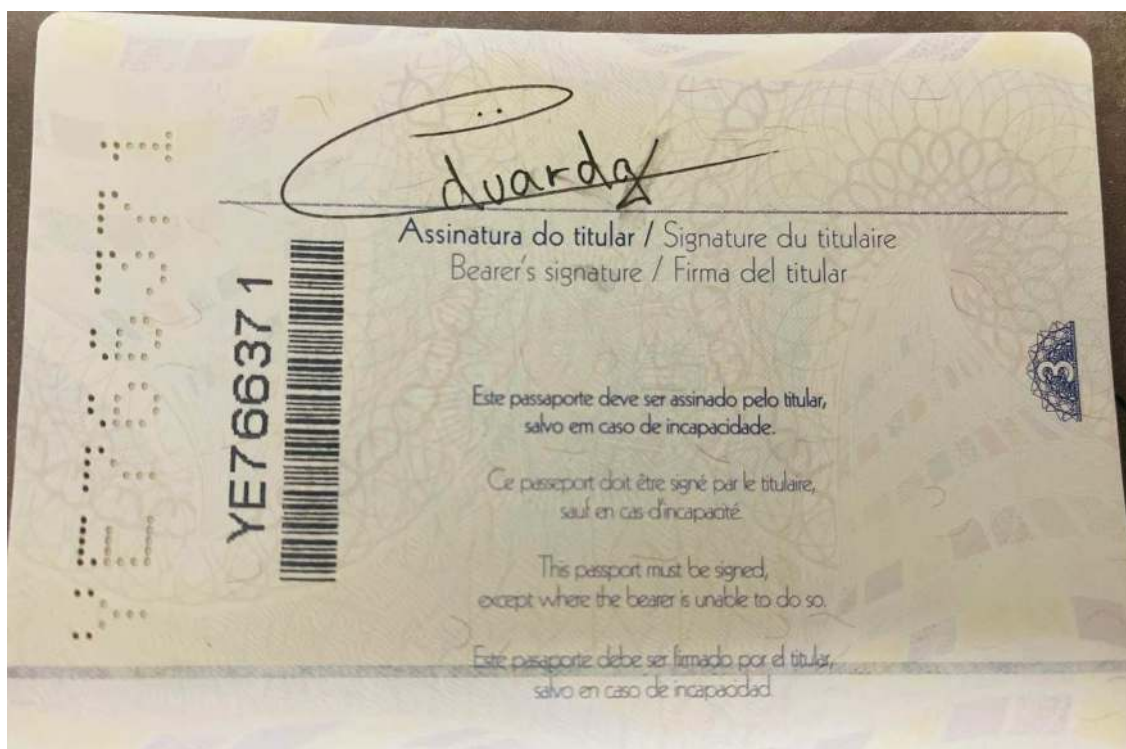
