Dear Sir or Madam,

Mr. João Vitor Pereira Figueiredo (A# 240-406-322) has an approved Form I-360, Petition for Amerasian, Widow(er), or Special Immigrant, classification SL6 (Special Immigrant Juvenile). The petition was filed with the National Benefits Center under receipt number MSC2590426850 by the undersigned counsel, acting as the authorized representative for the petitioner.

Despite undersigned counsel's best efforts over the last several months, there has been a material breakdown of communication between attorney and applicant. This has resulted in an irreparable and detrimental breakdown of the attorney-client relationship and a material breach of the representation agreement entered with his Petition.

Given the breakdown in the attorney-client relationship, applicant's unwillingness to cooperate, along with his failure to meet the conditions agreed upon in our representation agreement, I am unable to continue effectively representing Mr. João Vitor Pereira Figueiredo throughout his Petition. **Thus, undersigned counsel respectfully requests to withdraw from the Petitioner's case.**

Additionally, the undersigned counsel notes that the Motion to Withdraw as Counsel in the Petitioner's removal proceedings before the Executive Office for Immigration Review (EOIR) was granted by the Immigration Judge on April 8, 2026.



I hope this letter finds you well. Due to unsuccessful contact attempts over the past several months and your failure to fulfill contractual obligations, I am writing to formally notify you of the termination of legal representation in your case, in accordance with applicable ethical and legal regulations.

Since January of this year, we have attempted to contact you numerous times via telephone, messaging, and mail regarding your case. However, we have been unsuccessful. This lack of cooperation has hindered the progress of your proceedings and made it impossible to provide adequate legal services on your behalf.

Given this situation, maintaining our services has become unfeasible. Therefore, we have no alternative but to formally terminate our legal representation regarding your petition for Special Immigrant Juvenile Status (SIJS) before USCIS.

Permaneço disponível para fornecer informações adicionais sobre seu caso e orientações sobre os próximos passos, se necessário.


