My memories of childhood are strongly connected to my mother and my maternal family. I remember that my mother helped me with many things in my daily life. She helped me when I learned to play with an electric car I received from a family friend, she went on walks with me, took me to the Playground near my house, and I also remember swimming in the pool with her and, every night, going to sleep and praying with her. I have memories of her taking me to school by motorcycle and caring for me with affection. I also remember learning to ride a bicycle with my grandfather and my mother.

When I think about my family, the first thing that comes to my mind is my maternal family, my mother, my grandmother, and my godmother. I also remember my godfather (he is my father's brother). At school events, I remember the presence of my mother, my godmother, and my grandmother. On Father's Day events, the one who usually attended was my godfather.

Thinking about it, I do not have many memories of my father and mother together. The only memory I have is of one time when my father came to my house but did not want to come inside, and I stayed with him at the gate, outside on the street. He brought me a toy, although I do not remember what it was. What I know about their relationship is that my father cheated on my mother with another woman named Carol, and he married that woman.

I have few memories of my father during my childhood. I remember him showing up only a few times and inviting me to spend vacations with him. He took me once to a water park and to play soccer. I liked those moments, but I never wanted to spend vacations with him. As time went by, our relationship became even more distant. I cannot remember exactly when my father stopped contacting me because I was very young. I only know that I grew up with just my mother. The last time I saw my father I was around 11 years old. I remember that when I visited him, my sisters were still very young, like babies. Sometimes my father would have me take care of them when I was about 9 years old. I never wanted to visit him because the relationship felt strange to me, we never had an emotional bond. He never called or kept in contact with me, but would

suddenly appear wanting me to go with him. Today, my father does not call me, does not send messages, and does not participate in my life. When I turned 15, I believe he did not even remember my birthday. Even so, I do not see my father as a bad person. I remember him as someone playful, energetic, and who made jokes. However, he is not my real father to me. For me, a father is presence, support, care, and daily involvement, and that never existed between us. When I think of a father, the person who is present in my life is Junior, my stepfather. He helps me with my studies, guides me when I have problems, cares about me, and is teaching me how to drive. He truly participates in my life and makes me feel supported. If I had to return to Brazil and live with my father, I believe I would feel like the saddest person in the world, because it would be like living with a stranger. There is currently no coexistence, bond, or support between us. The idea of returning to live with someone who practically did not participate in my upbringing causes me fear, sadness, and emotional insecurity. In the United States, I feel safer and welcomed. Here I have stability, family support, and better opportunities to build my future. I have people who truly care for me, follow my life, and want what is best for me. Remaining here represents the chance for me to continue growing in a healthy, safe environment, and to move forward surrounded by the people who truly are part of my family.

My name is Kavya Morganna Soares Pinheiro, I am 32 years old, I was born in Paraíso do Tocantins, and I am the mother of Luís Otavio Pinheiro Coelho. I started dating when I was 15 years old, and at 17 I found out I was pregnant. At the time, Luís Otavio's father, Elber, asked me to have an abortion, as he was 19 years old and said he was too young to be a father, but this goes against my principles and in our country of origin this is a crime. So I already knew that I could only rely on my family, as they were the ones who helped me financially and emotionally, giving me the necessary support.

Since then, our relationship became troubled, because the more my belly grew, the less I could keep up with the father of Luís Otavio's routine, such as going out with friends and attending parties. And it kept getting harder and harder. Allegations began that he would not be able to help me with the financial needs of the pregnancy, but I remember all the times his car's sound system broke down, and on the same day he had it repaired, or when there were parties and he went to all of them, but he never accompanied me to routine check ups to see our child. I remember that on the day Luís Otavio was born, on 01/30/2011, there was a soccer match, while I was in the operating room in Palmas Tocantins, giving birth alone, he was watching the game and drinking with friends. Even after everything, I stayed with him because I did not want my son to grow up away from his father. So, we had agreed to stay together, as my dream was to have my family, graduate in dentistry, and achieve financial stability. He started college first, and after he graduated, he would help me take care of Luís Otavio and provide financially so that I could start my higher education program. When Luís Otavio turned 6 months old, he moved to another city to start college, so I stayed at home taking care of our son. He then started dating a classmate from college while still being in a relationship with me. This went on for 2 years until the girl decided to tell me. I decided to end the relationship, and with that he became more distant from our son, as he stopped making visits, attending school presentations, attending birthdays, spending Christmas with his son, or even making casual visits. This greatly affected Luís Otavio's well being, as he did not feel loved, and the paternal role was assumed by his grandfather. After Luís Otavio's

father graduated, he continued not to provide financial support, as he previously used the excuse that he was studying and could not help, after graduating, he said he was having difficulty finding a job, but even the emotional support that was requested, he made no effort to provide. My parents always helped us with financial, emotional, and material matters. They always helped us pay for Luís Otavio’s school, assisted us with health insurance, medications, school supplies, clothing, food, in short, all necessities.

Then, my father, Luís Otavio’s grandfather, was killed; he was a military police officer. He had become directly involved in a conflict with members of a criminal organization, and as a result, they began threatening him and vowed revenge against him and all the men in our family. After his death, these threats did not cease; on the contrary, they intensified, and we became targets of persecution by this criminal organization. During that period, police officers remained at our home providing security for approximately one week, until they informed us that they no longer had the resources to keep a patrol car assigned to our protection. As a result, we were forced to relocate to another city. Even during such a difficult time, Luís Otavio’s father offered no assistance, no temporary housing, and not even words of comfort.

From that point on, we lived in constant fear, knowing that we were being targeted. We were forced to move several times, including within the same city, always trying to avoid being found. I lived in a constant state of hypervigilance, afraid to establish any routine. There were days when I was even afraid to take Luís Otavio to school because I did not know whether we were being watched. As a result, he had to change schools several times, losing stability, friendships, and any sense of a normal childhood.

During this period, my brother assumed a paternal role in Luís Otavio’s life. However, as a result of the same persecution, he was kidnapped by the criminal organization and was never seen again, being subsequently declared deceased. This event was devastating for our family and confirmed that the threats against us were real and were being carried out. After that, it became clear to us that the men in our family were being targeted. Today, Luís Otavio is the last remaining male member of our immediate family, and I live in constant fear that, if we return to Brazil, he could suffer the same fate as his grandfather and uncle.

Despite everything that was happening, Luís Otavio’s father remained absent. During certain periods, he lived only about 40 minutes away from where we were living, yet he visited only rarely, occurring at most once or twice a year and always had excuses for not being present. I have always done my best, always cared for him, raised him, and filled him with love so that he would always feel welcomed.

Luis Otavio's father got married, had three children, and takes annual trips with his family. The only time he invited Luis Otavio to join one of these trips, he was around 10 years old, and at that time, after that visit, he came back with lice and with his back peeling from sunburn. Luis Otavio reported to me that he was in pain and discomfort, but he said that he did not feel comfortable complaining to his father.

We moved again to escape the threats and protect ourselves, but this time to another country. Today, we are here in the United States. Before making that decision, I spoke with his father, but he refused to provide housing, care, or protection. Today, Luis Otavio is 15 years old, and I continue to be his primary caregiver, providing him with love, care, protection, and support in all aspects of his life. Currently, Luis Otavio's father does not maintain contact with him and is not involved in his life in any way. There is no regular communication, nor any demonstration of interest in his well being, education, or development. This absence has been constant and further reinforces the fact that the entire responsibility for Luis Otavio's care, upbringing, and protection rests solely with me. He is a dedicated, respectful, and exemplary student, and my greatest goal is to ensure that he has the safety, stability, and opportunities necessary to build a secure and meaningful future.

Due to this prolonged absence and total lack of involvement, the father has failed to provide for the child’s health, safety, and welfare, leaving the child to depend entirely on his mother for stability, nurturing, and guidance. Because the father has not established a meaningful parental relationship and is not in a position to ensure the child’s well-being, reunification is not viable.

It is not in the child’s best interest to be returned to Brazil because doing so would jeopardize the child’s health, safety, and welfare. The child has no meaningful relationship with his father, who has been absent since his early childhood and has never provided consistent emotional, financial, or parental support. As a result, the child has grown up relying entirely on his mother for care, stability, guidance, and protection. Returning the child to Brazil would likely require him to reside with or depend upon a father who has abandoned him and failed to fulfill his parental responsibilities. The father is not in a position to provide a safe, stable, and supportive environment or to adequately meet the child’s needs. Additionally, the child and his family have been subjected to persecution and direct threats in Brazil, circumstances that contributed to the child’s departure from the country. Given the lack of a meaningful parental relationship with the father, the father’s inability to provide for the child’s health, safety, and welfare, and the safety concerns that exist in Brazil, it is not in the child’s best interest to be returned to Brazil.

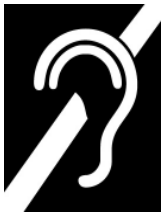

18 I, Otavio Haverroth Silva, attorney for the Petitioner/Minor Child, Luis Otavio Pinheiro Coelho,
19 hereby submit this Ex Parte Application to Advance the Hearing Date. The petitioner
20 respectfully requests that the Court set the hearing on the Custody Petition for a date on or before
June 23, 2026, for the reasons set forth below.

21 **I. Background**

22 The Child, Luis Otavio Pinheiro Coelho, is fifteen (15) years old and is currently in removal
23 proceedings before the Immigration Court. He has a Master Calendar Hearing scheduled for July
1, 2026. The Child is seeking Special Immigrant Juvenile Status (SIJS), which requires that a
24 state court issue specific findings regarding the child's dependency, abuse, neglect, or
abandonment prior to the filing of the SIJS petition with United States Citizenship and
Immigration Services (USCIS).

25 The Respondent Mother, Kavya Morganna Soares Pinheiro, is the child's biological mother, with
26 whom Luis Otavio currently resides in a stable and safe environment.

1 If the associated Special Findings are not adjudicated before the immigration court date, the child
2 will be unable to present his case for relief before the Immigration Judge, exposing him to a
severe and potentially irreparable risk of removal from the United States.

3 **II. Request for Advance Hearing Date**

4 The petitioner respectfully requests that the Court advance the hearing date to June 23, 2026, to
5 allow for the timely filing of the SIJS petition with USCIS prior to the Master Calendar Hearing
on July 1, 2026.

6 Given that the SIJS petition must be submitted to USCIS by mail, it is essential to account for the
7 time necessary to: (1) receive the Court's order granting the Special Findings; (2) prepare the
8 SIJS application package; and (3) allow for mailing and processing time before the immigration
9 hearing. A hearing date no later than June 23, 2026, represents the absolute latest date at which
the child could realistically secure and submit the necessary documentation before his July 1,
2026, immigration court appearance.

10 **III. Urgency and Good Cause:**

Good cause exists to advance the hearing date based on the following:

11 **Imminent Risk of Removal and Judicial Deadline:** The child is currently in removal
12 proceedings and faces a critical and imminent risk to his stability in the United States. The
13 Master Calendar Hearing on July 1, 2026, represents a hard deadline by which the child must
14 have the Special Findings in hand to preserve his eligibility for SIJS and other forms of
15 humanitarian relief. Failure to advance the hearing will result in procedural delays that would
effectively deny the child the opportunity to present his case for relief, leading to potentially
irreparable harm through deportation.

16 **Forms of Available Relief and Risk Mitigation:** Without the legal stability provided by this
17 proceedings and the corresponding Special Findings, the child remains vulnerable to removal
18 from his current household and from the country. It is paramount that the Court be informed that
the child has viable forms of relief available to him, relief that will be permanently foreclosed if
the hearing does not occur before the immigration court date.

19 **Respondent is the Biological Mother:** The Respondent is the Child's biological mother. Luis
20 Otavio already resides with her in a stable and safe environment. There is no risk to the child's
welfare in advancing this hearing.

21 **No Prejudice to Any Party:** Advancing the hearing date will not prejudice any party. The
22 petitioner and the Respondent are prepared to proceed on any date the Court may set. The
23 urgency is driven solely by the immigration court's calendar, which is outside the control of the
Petitioner and the Respondent.

24 **IV. Legal Basis for the Request:** California Rules of Court, Rule 3.1202, and the Court's
25 inherent authority to manage its calendar in the interest of justice provide the legal basis for this
26 application. The extraordinary circumstances of this case, namely, the child's pending removal
27 proceedings and the imminent immigration court deadline, constitute good cause to advance the
hearing. This request is made in good faith and for the sole purpose of ensuring that the child's
rights and available legal protections are fully preserved.

1 **V. Conclusion**

2 For the reasons set forth above, the petitioner respectfully requests that the Court grant this Ex
