RESPONDENT’S MOTION TO CHANGE VENUE

COMES NOW, Otavio Haverroth Silva, counsel for the above-referenced Respondents, Kacia Divina Cabral Taveira and Ecio Alves Taveira, and respectfully moves this Court, pursuant to 8 C.F.R. § 1003.20, to transfer venue of the above-captioned proceedings from the Immigration Court in San Francisco, California, to the Immigration Court with jurisdiction over Marietta, Georgia, and in support thereof states as follows:

The Respondents have permanently relocated from California to Georgia. Their current address is 3219 Windcliff Dr., Apt. 3202, Marietta, GA 30067; their former address was 205 Old County Road, Apartment 317, Belmont, CA 94002. In compliance with 8 C.F.R. § 1003.15(d), Respondents timely filed Form EOIR-33/IC with this Court on April 5, 2026, notifying the Court of their change of address. The Respondents are presently residing in Marietta, Georgia, and do not intend to return to California.

Requiring the Respondents to attend hearings in San Francisco would impose an undue financial and logistical burden upon them. The distance between Marietta, Georgia, and San Francisco, California, is approximately 2,400 miles, and the Respondents lack the financial means to travel repeatedly across the country for court appearances — including for the Individual Merits Hearing currently scheduled for December 16, 2027. Such a requirement would be inconsistent with the efficient and fair administration of justice.

Transferring venue to the Atlanta Immigration Court, which has jurisdiction over Marietta, Georgia, would allow the Respondents to obtain and present local witnesses and evidence, facilitate access to legal resources in their community, and ensure that proceedings are conducted in a manner that is practicable for all parties. No prejudice to the Department of Homeland Security would result from such a transfer, as DHS maintains representation in both jurisdictions.

For the foregoing reasons, Respondents respectfully request that this Court:

- Grant this Motion to Change Venue;
- Transfer venue of the above-captioned proceedings to the Atlanta Immigration Court, with jurisdiction over Marietta, Georgia;
- Vacate the Individual Merits Hearing currently scheduled for December 16, 2027, at the San Francisco Immigration Court; and
- Grant such other and further relief as this Court deems just and proper.
