**COMES NOW**, the undersigned attorney, Otavio Haverroth Silva, who comes, respectfully, in the capacity of counsel for the above-identified Respondents, to submit the present Supplemental Answer to the Scheduling Order, in strict compliance with the Finding of Removability and Scheduling Order, dated 01/07/2026, issued by this Honorable Court.

In response to the Court's Order, the Respondents state as follows:

1. Applications and prima facie evidence (Item 1(a)): Form I-589 (Application for Asylum and for Withholding of Removal) has already been filed in these proceedings. The supporting documentation and evidence pertinent to the Respondents' eligibility for asylum, withholding of removal, and protection under the Convention Against Torture (CAT) are part of the record and will be supplemented, as necessary, within the applicable deadlines;
2. Estimated duration of the individual hearing (Item 1(b)): the Respondents estimate that the individual hearing may require approximately 3 (three) hours, subject to adjustment depending on the dynamics of the proceedings;

3. Requested appearance format (Item 1(c)): the Respondents respectfully request that the individual hearing be held in person or, alternatively, remotely (internet-based), at the availability and discretion of this Honorable Court;
4. Interpreter (Item 1(d)): the Respondents' primary language is Brazilian Portuguese. Accordingly, the appointment of a Brazilian Portuguese interpreter is requested for all future hearings;
5. Voluntary departure (Item 1(e)): the Respondents do not intend to request voluntary departure, whether as the primary form of relief or in the alternative.

In view of the foregoing, the Respondents respectfully request that this Honorable Court accept the present Supplemental Answer as full compliance with the Scheduling Order dated 01/07/2026, noting the information required in items (a) through (e) of the Order.
